You have advised me that you consider all such information you furnish to be confidential, except to the extent such information is in the public domain.

Thank you for your inquiry about a PMMAL team.

In evaluating potential locations and potential owners and operators of PMMAL teams, the PMMAL will look closely at the demographics and other key elements of the market where the team will be located and the proposed playing venue; the reputation, experience and backgrounds of the members of the proposed ownership group; and whether the proposed owners have the financial capability and willingness to invest as required to acquire, launch and operate the team in a first class manner.

Accordingly, please furnish us with the following:

1. A written presentation that demonstrates the likelihood that a PMMAL team will be successful in the market in which you plan to locate the team, taking into account market size, demographics, corporate support and other characteristics of the market and history in the market regarding sports on the professional and collegiate level.
2. Identification of and business and financial information (including net worth) about the proposed owners of equity interests in the team, and the proposed structure of the ownership group. In this connection, please be aware that we favor a structure in which there is a “controlling owner” who has paid for a substantial equity interest and who has the sole power to make decisions relating to the team’s mixed martial arts, marketing and business operations. The structure may allow other owners to play a role in decisions outside of the ordinary course of the team’s business.
3. Detailed information about the proposed venue in which the team would play its home match, including size, location, condition, other tenants and other relevant information, if available at this time.
